

QAFCO was founded in 1969 as a joint venture between the State of Qatar, Norsk Hydro Norway, Davy Power gas, and Hambros Bank, to produce Ammonia & Urea by utilizing Qatar's abundant gas resources. The company is now owned by Industries Qatar (IQ) as 75% shareholder and Yara International as 25% shareholder. QOC wanted to improve Asset Management and traceability.

## Issues:

- Challenge with integration into DB2 using web service
- No Integrated Asset Management for Administration & IT departments
- Difficult to track Assets using existing manual system



## Solution:

- All asset information was tied into their existing JD Edwards system and the DB2 server
  - Asset visibility was heightened because of CATAMARAN's quick configuration of complex business rules
- Full asset visibility and tractability for anywhere
  - All assets were able to be easily monitored from a web application
- Reduced losses, misplacements, and timely searches
  - With a system that is easy to audit, it becomes much easier to look through the assets that were there
